**ELECTION TO THE VILLAGE HALL COMMITTEE**

**Mrs Frances Luck** , proposed by Dr Ian Brett, seconded by Mrs Wendy Camp. Unanimously agreed.

**ELECTION TO THE PLAYING FIELD COMMITTEE (1 member)**

**Mrs Jill Buck** was proposed by Mrs Jenny Miller, seconded by DR Ian Brett. Unanimously agreed.

**CONTRIBUTION TO THE UPKEEP OF THE NEW CHURCHYARD**

In 2012, at the request of the Parochial Church Council, the Parish Council had doubled the non-obligatory contribution annually made to £300.00 (Three hundred pounds). This was due to the rising costs of grass cutting.

**It was unanimously agreed to make the contribution of £300.00 again for 2013.**

**APPOINTMENT OF INTERNAL EXAMINER (Auditor)**

The books had been audited and approved by Mr David Binderfeld on 24<sup>th</sup> April 2013. He had expressed a willingness to carry out the work for year ending 31<sup>st</sup> Marc 2014.
