Notification of Pre-Submission Consultation under Regulation 14 of the Neighbourhood Planning  
(General) Regulations 2012**

Much Hadham Parish Council has produced a draft Neighbourhood Plan to help guide development in the parish.

Regulation 14 of The Neighbourhood Planning (General) Regulations 2012 requires that, before submitting the plan to East Herts Council for examination, the parish council must publish a pre-submission plan.

The Much Hadham Neighbourhood Plan contains policies which will become part of the statutory planning process. When the Plan is adopted, following a referendum, it will have equal weight to the East Herts District Plan in determining planning decisions within the Neighbourhood Plan Area (Much Hadham Parish).

The consultation commences on 12th August, when the full Neighbourhood Plan is available for download. Just look under 'pre-submission consultation' at site <https://www.muchhadhamnp.com/news>
