#### 1. Interests



#### 2. Adams Farm & Priory Farm proposed development

1. Report on the Bellis public meeting, 20th June

It was unfortunate that the GL Hearn rep was not present at the Parish Council meeting. The public display was very useful in showing what was being proposed. Over 120 attended and Bellis were surprised at the turnout, and also how many parishioners made similar objections. Thanks were extended to Mr Brickwood and Mr Gardner for writing so powerfully in the Magazine. The Parish Council cannot formally comment until it receives the application. It was recommended that individuals write objections to both Bellis and Hearn in advance in order to thwart the application if possible, even if comments were submitted on the form at the public meeting. It was further recommended that those letters are then copied to EHC Planning as and when an application is submitted. The Parish Council will object separately to EHC as a statutory consultee.

#### 2. Enough is Enough Group

It was unanimously **RESOLVED** that the Parish Council support the objectives and actions of the Enough is Enough Group.

Following a request from the floor, it was **RESOLVED** that the Clerk send East Herts Planning an FOI request to provide the Parish Council with copies of all minutes and notes of pre-application meetings and related discussions between East Herts Council and GL Hearn Ltd / Bellis Homes with regard to all possible development plans for the Adams Farm / Priory Farm site in Widford.

#### 1. Village Hall and archive

#### 2. Playing Field

There has not been a meeting recently and consequently there was no report.

#### 3. Allotments

**1. and 2.** The lack of a water supply dominates the concerns and the outcome of the consultation on taking out a loan is awaited. Tenants living nearby have trundled some water in, but it is a very difficult situation. Although some years ago, water was pumped from the ditch, there is no water in the ditch these days.

Some residents from Benningfield Road said there used to be another ditch behind their property that fed into the one by FP18, but this had been filled in and a hedge planted some 20 or more years ago by the landowner. It was contended that the ditch infill was illegal and the landowner should remove the hedge and re-open the ditch, which it was suggested was a statutory duty. The Parish Council was asked to look into the matter.

The Chairman said that responses to the loan consultation were fairly evenly divided.

#### 4. Closed Churchyard

As discussed under Finance 19.062.4 above, Lady Parker has offered to pay for the yew trees to be trimmed by David Jarrett.

#### 19.065 Highways, footpaths and byways

#### 1. Footpaths, footways and kerbs.

**1. FP6:** Nicholas Maddex has said he will write to the landowner again and ask that the FP be reinstated across the field.

#### 2. Highways

1. Cllr Paul Riddle reported on his meeting with Eric Buckmaster and Ian Hollinrake on 27th June 2019 to discuss the possible locations of SIDs within the village:

#### Much Hadham road

Not possible to put a SID anywhere in the 30mph zone because of the trees and the sight lines.	
It would be possible to put a 40mph SID on the bank opposite main entrance (not	
the Pegs Lane entrance) but this is a long way from the village.	
Sight lines would make it impossible to put a 40mph SID opposite Pegs Lane and a 40mph SID	EB/All

I suggested that the traffic counter was positioned at a particularly slow location which would	
skew the results and was told that it had to be at least 100 meters from the start of the 30mph	
zone so there is no option at this end of the village.	Clerk/
Eric was concerned that 5 or 6 houses have planning permission at the top of Pegs Lane and	JB
this could require an extension to the 30mph zone. PR to check planning approval.	
Ian suggested that the 30mph signs and "Widford Village" sign were hardly visible and on the	
wrong side of the road he agreed to look to see if anything could be done about this.	
Also a "white gate" type structure might help to show drivers they were entering a village. PR	
to follow this up with Eric.	

#### Hunsdon road

Again, Eric and Ian were unable to identify a better location for the traffic counter. If the Parish Council were to fund a second SID themselves there is a possible location at the road into Martlets adjacent to their sign.

#### Chicane

Eric to follow up the relocation of the chicane however he believes that the ball is in the developer's court.

#### Ware Road

Again, Eric and Ian were unable to identify a better location for the traffic counter. If the Parish Council were prepared to fund a third SID Ian would reluctantly look into the possibility of locating one at the end of the Willmore development, where the railings end but the sight lines and pavement width make this a difficult location.

Ian suggested that if required a number of sockets could be installed so two SIDs could be swapped between three locations. This assumes that Ian is able to confirm that the location at the end of the railings is acceptable.

#### **Parking Outside Ashview**

The resident living at the white house has requested a disabled parking bay which is difficult on a gravel road even if it is adopted.

Eric was uneasy about the stones which line the grass verge and Ian said that he should really remove them as they were a potential hazard. I urged him strongly not to do this. Eric suggested that he was prepared to look into installing proper bollards instead.

#### **Bus Shelter & Junction**

Looked at the damage to the new bus shelter and we all agreed that a bus stopping at the kerb would not hit the shelter in its current location. It is far more likely that the damage has been done by a lorry or van doing a three-point turn and reversing into it. The damage to the wooden tiles would suggest a blow from the front rather than a scrape.

The road through Widford is due to be resurfaced later this year but reducing the camber at the bus stop would not help.

The pavement at the bus stop may well be raised but this would have no impact as the pavement would be no wider.

I suggested a mini roundabout would reduce speeds through the village but with no serious injuries reported the cost cannot be justified.

I suggested a stop sign rather than just give way sign and Ian felt that this might be a possibility and will give the idea some thought.

Following the report, various courses of action were suggested, including asking the landowner to cut back the trees on the hill south of the Pegs Lane junction to improve sight lines that

would enable a SID to be located at the top of the hill. There was not a consensus on this as there is no guarantee it would produce a positive outcome. There were also reservations in respect of the Conservation Area.

It was noted that the only location at the moment is on the Hunsdon Road.

The use of village gateway devices and signs might create a better awareness that drivers were entering a village space.

**2.** Bus shelter repair: The contractor will repair the damaged roof free of charge and will install the seat at the same time – no indication of when that might happen.

3. TRO 13050: The temporary closure of the B180 was noted.
